2. 2021 World Anti-Doping Code

THE CHAIRMAN said that the Members had heard from Mr Young during the Executive Committee discussions about the three very minor alterations. It was a formidable document and he had been very impressed by the quality of the interjections and even more impressed by the way in which Mr Young and Professor Haas had dealt with them throughout the meeting. The Code had been on the agenda in its various forms for some two years; the final version was in shape and he formally submitted to the Foundation Board that it adopt the revised World Anti-Doping Code.

DECISION

Proposed 2021 World Anti-Doping Code approved.

3. Any other business/future meetings

THE DIRECTOR GENERAL said that there would be a Conference Declaration, which had been drafted by a working group, at the upcoming Conference plenary session. The working group was putting the finishing touches to the Declaration, which would be read out and then made immediately available to all of the Conference participants.
